

PHYSICAL COUNSELING FLOW

The Director of Sikkim Manipal Institute of Technology (SMIT) will address the session for the students & parents in brief and initiate the physical counseling round each day.

• The sequence of the reporting formalities are as follows:



• Step 01: Documents Verification & Submission

Students are required to bring the following documents in original and one set of self-attested photocopies while reporting to join their course at SMIT:

- i) Mark Sheet & Pass Certificate of Class X and XII
- ii) Diploma Certificate for Lateral Entry Students only
- iii) Graduation Certificate for Post Graduation Students only
- iv) Migration, Transfer and Character/Conduct Certificate
- v) Rank Card(JEE / CUET / MET / Any Alternative)
- vi) Student's and Parent's Aadhaar Card
- vii) Parent's PAN Card
- viii) 4 Passport size & 2 stamp size photograph of the student
- ix) Anti Ragging undertaking reference no. as per UGC regulation. Students must fill Anti-ragging affidavit before reporting and bring a copy of the affidavit. Use the link: https://www.antiragging.in/affidavit_affiliated_form.php

- x) Scholarship form (Last Date of Application 15th August); (the format is enclosed on page no.- 13)

• Step 02: Medical Check-Up

i) All the students are required to get their medical check-up done by a registered medical practitioner and to submit the same while reporting (Medical Check-up report) at SMIT. The medical certificate is mandatory. The format is enclosed on page no.-12.

• Step 03: Fee Payment

- i) The fee is to be paid as per the table below after deducting the amount already paid during provisional admission/seat booking.
- ii) The seat booking amount paid by the candidate will be adjusted from the course fee.
- iii) Fee can be paid using any of the below mentioned modes:
 - A. Online Fee Payment to be done via your students dashboard.(E-Campus)
 - Steps: 1. Login to ecm.org.in (using your E-Campus cradentials- will be shared shortly)
 - 2. Go through the instruction page and click on proceed for payment button.
 - 3. You may pay via UPI/ Cards/ Online Banking and download your fee receipt.

- iii) Last date for Fee Payment will be 30th June(for all Even Semester) and 30th December(for all Odd Semester). Except newly admitted First Semester/Lateral Entry Students.

• Step 04: Personal data update at E-campus and Teacher Guardian (TG) Interaction

- i) ID creation and personal data would be updated in E-campus portal.
- ii) Teacher Guardian allotment, & details will be shared in due course of time.
- iii) The respective TG will be present on the campus to assist students with all the reporting/counseling activities.
- iv) Students & Parents are further advised to be in touch with their TGs for any type of query throughout their study at SMIT.

• Step 05: Hostel Room Allotment / Hostel Kit Collection

- i) Hostel allotment, and floor warden details will be shared in due course of time.
- ♦ At SMIT Campus: A welcome reception desk will be present at Hostel No:3 (Directional signage is placed at the main gate to guide parents & students). A flow chart of a process for student reporting will be shared with the students at the reception desk on arrival.

SCHOLARSHIPS

SMIT offers a variety of scholarships to support and reward meritorious and deserving students. All newly admitted students are encouraged to go through the eligibility criteria and submit the required documents for scholarship consideration at the time of reporting.

Instructions:

- i) Eligible students must fill the attached Scholarship Application Form and submit it along with supporting documents during physical reporting.
- ii) Students may apply for only one category of scholarship.
- iii) Submission of forged/incorrect documents will lead to disqualification and disciplinary action.
- iv) All scholarships are subject to the verification and approval of the institute's Scholarship Committee.

INSTRUCTIONS FOR INTERNATIONAL STUDENTS

All newly admitted international students reporting to the Institute are required to follow the guidelines below for a smooth onboarding process and to ensure compliance with government regulations:

i) FEE PAYMENT INSTRUCTIONS: Fee payment to be made as per bank details provided on Page No. 3.

ii) INNER LINE PERMIT (ILP):

International students must obtain a temporary Inner Line Permit (ILP) at the time of entering Sikkim. The ILP can be availed from the Tourism Office at the Rangpo Check Post.

To obtain the ILP, students must produce the following:

- Students from Nepal: Original and photocopy of Nagarikta Certificate or Passport, and two passport-size photographs.
- Students from other foreign countries: Original and photocopy of Passport and Visa, along with two passport-size photographs.

iii) FRO REGISTRATION:

All foreign nationals (except students from Nepal) are required to register with the Foreigners Registration Office (FRO), Gangtok, within 14 days of their arrival at SMIT.

iv) DOCUMENTS TO BRING AT THE TIME OF REPORTING:

All international students are advised to carry the following documents:

- Students from Nepal: Original and one photocopy of Nagarikta Certificate/Passport.
- Other International Students: Original and one photocopy of Passport and Visa.
- All Students: Four passport-size photographs.

v) SUBMISSION OF ILP AT SMIT:

• Upon arrival at SMIT, all international students must submit a copy of their temporary ILP to the Office of the International Collaboration Cell.

• This is essential for initiating the process of obtaining a long-duration Inner Line Permit from the Home Department, Government of Sikkim.

- All the percentage mentioned above are based on the candidate's undergraduate results for all PG courses admission.
- The Candidate should provide class 12th board/UG passing certificate (pass in all the subject) to avail any scholarship scheme in SMIT.
- Candidates can avail only one type of scholarship. Scholarship Schemes are applicable for the entire duration of their study, subject to fulfillment of criteria of CGPA ≥ 7.5 with no backlog and no disciplinary case.
- **The scholarship applicable to the economically weak students based upon the income of the parents /guardian (in absence of living or working parents) subject to verification of requisite documents by competent authority of SMIT case to case basis as per availability.
- **Required Documents: Application for special scholarship along with a mandatory (any) two documents from the below mentioned certificates need to submit through Chairman Admission for approval from HoI in advance:
 - a) Income Certificate issued from District Magistrate (Preferred)/SDO/SDM.
 - b) Income Affidavit from Notary by parents at the commencement of each semester.
 - c) Income Tax return (ITR V "Acknowledgment receipt" of two preceding financial years.)
- Scholarships are provided as per the university policy.

Note: Scholarship will only be effective once the documents are found to be true and verified by the Institute's Scholarship committee .The list of the Scholarship awardees will be put up in the institutes notice board.
